INVITATION TO BID

The DILG Regional Office No. V, through the Bottom Up Budgeting 2013, A Program funded by the GAA Provision for Potable Water Supply intends to apply the sum of Two Million Pesos (Php2,000,000.00) being the Approved Budget of the Contract (ABC) to payments under the contract DILGCW-2013-09-0026. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The DILG now invites bids for the Design & Build for the Construction of Level II Water Supply System at Pagatpatan, Bato, Cam. Sur. Completion of the works is required in seventy two (72) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion

as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five (75%) interest of outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the DILG-BAC Secretariat and inspect the Bidding Documents at the address given below from 9:00AM – 5:00PM.

5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos (Php 5,000.00).

6. The DILG will hold a Pre-Bid Conference on September 25, 2013 at 9:30AM at DILG Regional Office No. V Conference Room, Rizal St., Legazpi City, which shall be open to all interested parties who have purchased the Bidding Documents.

7. Bids must be delivered to the address below on or before 9:30AM On October 9, 2013. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
