In general, the tasks and function of the CMs is to ensure the implementation of the grassroots planning and budgeting process as indicated in the Joint Memorandum Circular and facilitate civil society participation in local governance.

The applicant must have the following qualifications:

Education: Graduate of any 4 year course relevant to social development, community development, and/or social work. Undergraduates who possess at least 3 years experience in community development, social work, and participatory local governance may also be considered.

approaches. Experience: at least 1 year of relevant, progressive work experience in community organizing and/or social development work. Experience in Participatory Local Governance will be an advantage.

Other qualifications: Must have a strong sense of social responsibility, credible/able to work with Civil Society Organizations and local government units, able to communicate verbally and in writing to various stakeholders, be fluent in the local dialect and/or a resident of the area to which he or she will be assigned and computer literate
