**PROCUREMENT OF GENERATOR SETS FOR USE IN THE PROVINCIAL OFFICES OF DILG

**SUPPLEMENTAL BID BULLETIN No. 1**

The DILG REGIONAL OFFICE V hereby announces, pursuant to Sec. 22.5 of the IRR of R. A. 9184 that the **Bid Opening and Last Day of Submission of Bid Documents** for the PROCUREMENT OF GENERATOR SETS FOR USE IN THE PROVINCIAL OFFICES OF DILG V IN THE CALENDAR YEAR OF 2022 **on November 17, 2021, shall be moved at a later date, November 25, 2021** due to conflict of schedule of the Finance and Administrative Division (FAD) which the Bids and Awards Committee (BAC) is a part of, and to give more time for the BAC to issue a proper Supplemental Bid Bulletin answering the questions/queries made by prospective bidders during the pre-bid conference last November 5, 2021.



The FAD shall have a Strategic Planning on November 15-17, 2021. During which, the staff will be unavailable for any official transaction, and therefore, cannot commence with the supposed Bid Opening. It should also be noted that the **BAC will not be able to accept any submission of Bid Documents during November 15-17, 2021.**

The BAC requires more time to answer the following questions/queries from each DILG V Provincial Offices:

1. Distance of line (wire) connection between the Generator and the Office Building.
2. Are the current generators (if existing) of each province single or triple phase?
3. Do they have Automatic Switch (ATS)?
4. Does each province already have a GenSet Pad?
5. Does each province require additional specifications for the GenSets?
