**SUPPLEMENTAL BID BULLETIN No. 1**

In consideration of the queries, clarifications, recommendations, and suggestions, the DILG REGIONAL OFFICE V hereby include, revise, amend, delete, and/or adapt the following pursuant to Sec. 22.5 of the IRR of R. A. 9184:

1. Reminder that **each bidder shall submit three (3) copies of the first and second components of its bid, and properly put tabs for each document for ease of access and identification.** The Procuring Entity may request additional hard copies and/or electronic copies of the Bid.
2. **Each bidder shall also attach in the technical component of their bid a Cost Distribution Matrix following the latest DOLE Matrix.**
3. The following changes regarding the technical specifications prescribed in the public bidding document are now amended:

**Uniform and Equipment (Regional and Provincial Office):**

**Regional Office:**

- a. 1 Shotgun with 12 rounds of ammunition **(for night shift guards)**
- b. 1 9mm Pistol with 2 magazines and 14 rounds of ammunition
- c. **Searchlight** with Regular Supplies of Batteries/ or Rechargeable Batteries
- d. Basic First Aid Kit

**Provincial Offices (Albay, Cam Norte, Catanduanes, Sorsogon):**

- a. 1 Shotgun with 12 rounds of ammunition **(removed)**
- b. 1 9mm Pistol with 2 magazines and 14 rounds of ammunition
- c. Searchlight with Regular Supplies of Batteries/ or Rechargeable Batteries **(added)**
- d. Basic First Aid Kit **(added)**

4. The BAC, **upon post-qualification shall conduct a Mandatory Background Investigation.**
5. Reminder that the DILG Regional Office V shall **inspect the remittances or payroll made to the security guards of the winning bidder.**

All provisions of the bidding document that are affected by the newly issued bidding documents templates are deemed modified/amended/Revised.

Amendments/clarifications made herein shall be considered an integral part of the Bidding Document.
