SUPPLEMENTAL BID BULLETIN No. 1

In consideration of the queries, clarifications, recommendations, and suggestions, the DILG REGIONAL OFFICE V hereby include, revise, amend, delete, and/or adapt the following pursuant to Sec. 22.5 of the IRR of R. A. 9184:

1. All prospective Bidders are **required to submit actual sample of each item to be included in the Bid Documents, to expedite the post qualification process.**
2. **Payment for the applicable fee of the Public Bidding Document may now be conducted online thru GCash** number: 09959107757, under Maria Concepth C. De Guzman.
3. **A Land Bank account is mandatory to all prospective bidders** as prescribed by the Commission on Audit (COA).
4. **The Bid Opening on November 10, 2021 may now be attended online through Google Meet.** Meeting details are as follows:

5. To ensure compliance for certification of items as required by COA, **the requirements are hereby revised** as follows:
 - a. **Face Mask** – Certificate of Medical Device Notification (CMDN) or Certificate of Product Registration (CPR)
 - b. **Face Shield** - non-required but other certification will be accepted

- c. **Alcohol** – Certificate of Product Registration (CPR) or Certificate of Product Notification (CPN)
 - d. **PPE GOWN** (Bunny Suit Cover-All) – non-required but other certification will be accepted
 - e. **Head Cover** – non-required but other certification will be accepted
 - f. **Shoe/Foot Cover** – non-required but other certification will be accepted
 - g. **Goggles** – non-required but other certification will be accepted
 - h. **Gloves** – Certificate of Product Registration (CPR) or Certificate of Medical Device Notification (CMDN)\
6. **Delivery and inspection shall be at the DILG Regional Office V, to be distributed to the various Provincial Offices of DILG V by the winning bidder.**
7. **Reiteration of Section II** – Instruction to Bidders regarding SLCCs:

Pursuant to Section 23.4.1.3 of the 2016 revised IRR of RA No.9184, the Bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to:

- a. For procurement where the Procuring Entity has determined, after the conduct of market research, that imposition of either (a) or (b) will likely result to failure of bidding or monopoly that will defeat the purpose of public bidding: the Bidder should comply with the following requirements:
 - i. Completed at least one (1) similar contract, the aggregate amount of which should be equivalent to at least *fifty percent (50%) in the case of non-expendable supplies and services or twenty-five percent (25%) in the case of expendable supplies*] of the ABC for this Project; and
 - ii. The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above.

All provisions of the bidding document that are affected by the newly issued bidding documents templates are deemed modified / amended / revised.

Amendments / clarifications made herein shall be considered an integral part of the Bidding Document.
