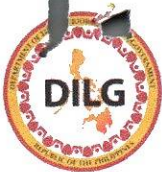

BAC RESOLUTION AWARDING TO “NUPRINT MASTER “AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB) THE PRINTING OF RCSP COFFEE TABLE BOOK FOR THE DILG 5

WHEREAS, the Procuring Entity, Department of the Interior and Local Government Regional Office No.5, requested the quotation for the **Printing of RCSP Coffee Table Book for the DILG 5 Showcase of RCSP and SBDP Milestones (during Regional Peace and Development Summit for Mayors)** with an approved budget for the contract (ABC): One Hundred Nineteen Thousand Pesos (119,000.00).

WHEREAS, the BAC resorted to **SMALL VALUE PROCUREMENT (53.9)** as an alternative mode of procurement posted in the Project Bulletin Board for the period from September 22, 2023 to September 26, 2023.

WHEREAS, there are Seven (7) bidders who submitted their quotations. After the Bid opening, the BAC found that Nuprint master with a bid amount of Php 92,750.00, was rank 1. J&E Printing Press with a bid amount of Php 108,500.00 was rank 2. AG3 Printing Press with a bid amount of Php 108,899.00, was rank 3. Zurbano Publishing & Printing Corp. with a bid amount of Php 118,870.00 was rank 4. J2MV Graphic Design Services with a bid amount of Php 172,099.90 was exceeded ABC. Triple J Printing Press was disqualified due to No Attachment/No Philgeps Number. Palanca Printing Press was disqualified because no RFQ was returned.
